The Club expanded its mission to include the greater Washington area (DMV). Among the Foundations service accomplishments in 2023, it gave \$195,000 in grants to entities in the DMV and \$28,900 to international entities. It also provided \$7,000 in support of a career fair for students at Richard Wright Charter School, \$10,000 for luggage for foster children and \$4,000 to various entities that were victims of natural disasters.
